

FUNSIDE BALATON PARENTAL DISCLAIMER FORM | NAME OF CHILD:

- 1. As the parent or legal guardian of the child/children attending the camp (hereinafter referred to as: Parent), I hereby declare that my Child can attend during the given time period and under the conditions stated below the Funside Balaton Summer Camp (located at Györöki Ifitábor, Balatongyörök, Hungary and outside locations). I understand that my Child can attend the camp only with my explicit permission and under the conditions stated below.
- 2. The Organizers of the Camp declare that they will act to the best of their knowledge to ensure the quality of the education and activities provided to the Child. By signing the General Terms and Conditions, the Organizers of the Camp also declare that in the given period they will provide the participants of the Camp three meals a day, as well as beverages. The Organizers of the Camp declare that the Child may not leave the Camp in the absence of the Parents or without the explicit request or permission of the Parent. The Child may only be picked up from the Camp by the Parent or legal guardian, or any third person authorized by them. The Organizers of the Camp are only responsible as far as the obligations stated in the Camp Policy are concerned; in any other cases, the responsibility relies solely on the Parent. Under the Civil Code of the Hungarian State, the Parent is liable for any possible damages to the Camp's equipment or premises caused by the Child.
- **3.** The Parent declares that he or she has listed all known illnesses of the Child in the Camp's official sign-up form. The organizers of the Camp are not liable for any injuries caused by illnesses not stated in the sign-up form. By signing the General Terms and Conditions, the Parent understands and declares that the Child will participate in sports and other activities at one's own risk. The Organizers of the Camp are not liable for injuries resulting from these activities. If the Child is not a Hungarian citizen and therefore the Child is not entitled to Hungarian social security (TAJ) benefits, the Child must have a valid EU health insurance card, or travel and accident insurance for the entire duration of his or her stay at the Camp. If the child arrives at the camp with neither a valid TAJ card, nor a valid EU health insurance card, nor a certificate of travel insurance taken out for the entire duration of the camp, then the Organizers of the camp may refuse the child entry to the camp without a refund. In the event that the Child requires medical care during the camp, any costs that arise as the result of such care, that are not covered by the Child's insurance or the camp insurance, must be paid by the Parents. In case the Camp covers any such cost on the spot, the Parents must reimburse these costs by the end of the Child's stay.

Special meals: when registering, please note that campers eat in the same place as their peers, so even in the case of cross-contamination-free meals prepared in a separate kitchen, it is not 100% certain that gluten or other allergens are not in the air.

**4.** Cancellations: in case of cancellation due to illness or any other reason prior to the camp, the Camp Organizers will try their best to find someone from the waiting list to take over the place in question. If another Child (a newly signed up camper or someone from our waiting list) is able to take the place of the Child at the camp, then only the 5% service fee is charged, the remainder of the standard camp fees is fully refunded. If the canceled camp is a premium camp, then 'extra fee' of the premium class (e.g. the extra cost of Windsurfing, Horseback riding etc.) is only refunded if the newly signed up camper chooses the same class; otherwise this cost is not refunded. In order to have the best chance of a full refund, it is best to notify the Organizers as early as possible about a potential cancellation. It's never a good idea to join the camp while being ill – should this be the case, please get in touch with our team as early as possible so that we can find the best solution for you.

In case the Organizers are unable to fill the place in question (there is nobody on the waiting list able to take over the place), then due to the costs regarding housing, meals, personal costs etc. in connection with that place already partially or fully spent, refunds may only be issued with the following conditions:

- A 95% of the full camp fee is refunded if the cancellation happens up to the Monday two weeks before the given camp week (only a 5% service fee is charged from the full camp fee). If the cancellation happens following this date but up to the Wednesday before the given camp week, then 80% of the full camp fee is refunded. Any cancellation that happens from Thursday to Saturday before the given week permits a 50% refund of the camp fees. In case of no show or a withdrawal from the camp after the camp week has begun, no refund is issued.
- In case a camper keeps their booking but cancels or substitutes a 'premium fee' class (e.g. Windsurfing, Horseback riding etc.) up to the Monday two weeks before the given camp week, the full cost of the extra fee is refunded. If the cancellation happens following this date but up to the Wednesday before the given camp week, then 80% of the extra fee is refunded. Any cancellation that happens from Thursday to Saturday before the given week permits a 50% refund of the extra fees. In case the class is cancelled by the camper or the parent on the first day of camp, or later, then no refund is issued for the extra fee.

In the case of the Camper getting ill during the Camp, forcing them to leave the Camp or spending time in isolation within the Camp, the Organizers cannot be held responsible and the illness does not provide ground for a refund.

If the authorities impose mandatory quarantine on the Camper and thus they cannot continue participating in a week which has already begun, there is no ground for a refund.

All changes to be possibly made due to legal/public health instructions do not provide grounds for a refund or an extraordinary cancellation.

Cancellations must always be made in writing. Refunds are then issued within 30 days of the cancellation to the person who made the original payment.

**5.** Possible instances for the cancellation of the camp and possible following actions:

If the chosen camp is cancelled by the Organizers of the Camp for any reason, the Organizers of the Camp will issue a full refund, or on request may credit the camp fee towards another camp.

In case overnight (sleepover) camps become legally prohibited by the Hungarian government in 2024, and therefore the camp cannot go ahead this year, and this legal measure takes effect prior to 1 June 2024, anyone who has already made a payment is eligible for a full refund, or a voucher for next year's camp of the same value, whichever one the payer prefers. The voucher cannot be later exchanged to cash.

In case overnight (sleepover) camps become legally prohibited by the Hungarian government in 2024, and therefore the camp cannot go ahead this year, and this legal measure takes effect on 1 June 2024 or later, anyone who has already made a payment will receive a voucher of the same value. The voucher can be redeemed in 2025, for Funside Balaton summer camps. The voucher cannot be exchanged to cash.

- **6.** By attending camps organized by the Funside Association, the Child receives a supporting membership of the association, valid until December 31, 2024.
- **7.** Any photos or videos taken at the Camp are the property of the Camp. The Camp maintains all the rights. The parents accept that photos may be taken at programs or activities where the child participates.
- **8.** Campers must not have any medications, especially prescription drugs, in their possession during the camp, they must not take any drugs without the explicit knowledge of Camp Management and must not give medications to other campers under any circumstances. In order to ensure this, it is strictly forbidden to bring any drugs to camp without first notifying Camp Management (violation of these rules will result in the parents baring full responsibility for the consequences of any such action).
- **9.** The Camp Registration Form, as filled out by a parent or other legal representative of the Child electronically or on paper, is part of the General Terms and Conditions. Parents are responsible of the validity of the information provided about the Child on the Form.
- **10.** The <u>Camp Policy</u> is part of the General Terms and Conditions. The Parent verifies with his or her signature that he or she and the Child have read and understood the Camp Policy. The Camp Policy can be found on the webpage of the Camp and is directly available to any parent on request.
- **11.** The camp fees may be paid via bank transfer or by debit or credit card. The debit or credit card payments are processed through Barion.

The present General Terms and Conditions is the official translation of the original document, written in the Hungarian language. In case of any disputes, the original General Terms and Conditions shall prevail.
